# **Nebraska**

This Student Data Privacy Agreement ("**DPA**") is entered into on the date of full execution (the "**Effective Date**") and is entered into by and between: Louisville Public Schools (the "**Local Education Agency**" or "**LEA**") and Amplify Education, Inc. (the "**Provider**").

**WHEREAS**, the Provider is providing educational or digital services to LEA.

WHEREAS, the Provider and LEA recognize the need to protect personally identifiable student information and other regulated data exchanged between them as required by applicable laws and regulations, such as the Family Educational Rights and Privacy Act ("FERPA") at 20 U.S.C. § 1232g (34 CFR Part 99); the Children's Online Privacy Protection Act ("COPPA") at 15 U.S.C. § 6501-6506 (16 CFR Part 312), applicable state privacy laws and regulations and

**WHEREAS**, the documents and data transferred from LEAs and created by the Provider's Services may be also subject to several state laws in Nebraska. Specifically, those laws include Neb. Rev. Stat. Secs. 79-2,104; 79-2,153 to 79-2,155; 79-2, 539; 87-801 to 87-808; and 92 NAC 6; and

**WHEREAS**, the Provider and LEA desire to enter into this DPA for the purpose of establishing their respective obligations and duties in order to comply with applicable laws and regulations.

**NOW THEREFORE,** for good and valuable consideration, the parties agree as follows:

- 1. Provider agrees to offer the LEA all the same terms and conditions found in the MA-ME-MO-NH-NY-OH-RI-VT-DPA, Modified Version 1.0 Data Privacy Agreement between the Provider and Manchester School District ("Originating LEA") which is dated 08/23/2024 ("Originating DPA"). The terms and conditions of the Originating DPA are thus incorporated herein.
- 2. Provider additionally agrees to the following additional terms, which will control in the event of a conflict between the DPA and the Originating DPA:
  - a. In Article II, Section 5, add, "Specifically, any written agreement with a Subprocessor will: (1) prohibit the Subprocessor from using Student Data for any purpose other than providing the contracted service to or on behalf of the Provider; (2) prohibit the Subprocessor from disclosing any Student Data provided by the Provider with subsequent third parties for any purpose other than providing a contracted service to or on behalf of the Subprocessor; (3) and require the Subprocessor to implement and maintain reasonable security procedures and practices."
  - b. In Article IV, Section 2, replace "otherwise authorized," with "otherwise required" and delete "or stated in the Service Agreement."
  - c. In Article IV, Section 4, replace: "Provider will not Sell Student Data to any third party" with "Provider will not Sell or rent Student Data to any third party.
  - d. All employees of the Provider who will have direct contact with students shall pass criminal background checks.
  - e. In Article V, Section 1 Data Storage: Nebraska does not require data to be stored within the United States.
